NOW, THEREFORE, BE IT ORDAINED by the Mayor and Borough Council of the Borough of Paulsboro, County of Gloucester and State of New Jersey on this 3<sup>rd</sup> day of February, 2015 that Chapter 45A is hereby amended as follows:


**§45A-3.2. Applications for functions at parks.**

(E.) All applicants must provide evidence of General Liability Insurance; minimum limit is pursuant to the amount stated in the facilities use agreement. The policy shall name the Borough of Paulsboro as an additional insured. All terms and conditions of the facilities use agreement must be adhered to.

BE IT FURTHER ORDAINED by Mayor and Council that all ordinances or parts of ordinances inconsistent with this amending ordinance are hereby repealed to the extent of their inconsistencies only.


