O. #08.21: AMEMDED ORDINANCE OF THE BOROUGH OF PAULSBORO ADOPTING AN AMENDMENT TO THE REDEVELOPMENT PLAN FOR THE ENTIRETY OF THE BOROUGH OF PAULSBORO, COUNTY OF GLOUCESTER, STATE OF NEW JERSEY TO PERMIT CANNABIS CULTIVATORS, MANUFACTURERS, WHOLESALERS, DISTRIBUTORS, RETAILERS AND DELIVERY SERVICES WITH THE MANUFACTURING DISTRICT.
